

Dee Why Village Plaza - SHOP & WIN BACK Competition

Terms and Conditions

1.Promoter:

2.Promotion Period:

The Promotion commences at 9:00am AEDT on Wednesday 9th July 2025 and concludes at 12:00pm AEDT on Wednesday 30th July 2025.

3.Eligibility:

- Entry is open to all eligible customers aged 18 years or older.
